Supply Minister's Report

Rev. Dr. Garry van Bruchem (Retired)

In January 2020, I retired from the ministry with no plans to serve the church except as a member of a congregation, but six weeks later a pandemic was declared. In December, Delta United Church's Search Committee approached to ask if I would be willing to serve as their minister in 2021. At that time, churches were not permitted to conduct in-person services, so I proposed that we hold worship on Zoom. This way, the congregation also would have opportunities to visit virtually every week, check in with neighbours, and share news. This was new for Delta United Church, but everyone did their part to make it work.

Trish Fraser and Cathy Scott met with Heather Kilborn and Patrick McPhail in the church to make audio recordings of the hymns. Shiona Mackenzie produced weekly slides with the words to the hymns and readings. Lay readers did their parts from home. Sarah Ferguson, LLWL, hosted the Zoom meetings and posted the recordings on Facebook. Everyone figured out how to use Zoom on their computers, and we were able to hold services virtually. It was a steep learning curve for us all to climb, but on most Sundays we had almost as many people joining us on Zoom as we would have had in person. It wasn't as good as being together, but it was the next best thing. Recordings of the services were posted on Facebook and several people took in the service whenever they could.

Other meetings took place on Zoom, too. Council meetings, Worship and Christian Education meetings, Pastoral Care Committee meetings, Re-opening Committee meetings, Trustees meetings, Affirm planning meetings, even the Annual Meeting, all happened with people participating in front of computer screens. And it worked! We got the business of the church done properly, efficiently and safely.

There were two accomplishments in 2021 that DUC would remember, whether or not there had been a pandemic. One is that you were able to complete the Affirm Process by having your celebration virtually. You can now say proudly that Delta United Church is an Affirming Congregation within the United Church of Canada. The welcome is inclusive: Public, Intentional and Explicit = PIE.

The second accomplishment is that Delta United Church replaced the church roof. The old shingles were curled, and leaking, and overdue for replacement. Thanks to the work of the Trustees, the contractor was hired and the work was completed over the summer. You are making very good progress in paying for the new roof, too. Hopefully this can be completed by the end of 2022.

In September, we returned to in-person worship and I got to meet you face to face for the first time. Well, half-face to half-face – we still had to wear our masks and keep our social distance. At times, that feels unfriendly, but many of us are in the vulnerable category so it's best to keep everyone safe.

Delta United Church has experienced many changes in 2021. Worship changed when Rev, Shelley moved on to another church. We haven't been able to sing in church. Heather is occasionally with us, but DUC is now looking for its next music director. Denise Forget left us, but DUC hired Maggie Ford to do its children's program. We haven't been able to have a coffee hour after the service and, of course, Delta United Church is still looking for its next minister. The year 2021 brought many changes!

But many more things have not changed. Delta United Church continues to experience a rich Christian fellowship with ongoing worship to sustain your faith. DUC's ministry in the community, through Edith's Pantry, and support of Wesley Urban Ministries, continues. The United Church Women group (UCW) has resumed its meetings and its work. The Mission and Service Fund of the United Church is still well-supported. People still call on one another demonstrating care and praying for one another, especially when life gets difficult.

The Bible's testimony is that God is faithful. I believe God's faithfulness is best experienced when God's people are faithful. In 2021, Delta United Church remained a faithful congregation. No one knows what the future will hold, but, whatever the circumstances, God's people will always have opportunities to remain faithful.

I have enjoyed the year that we got to spend together, both online and in person. In 2022, I am planning to resume my retirement.

Council Chair's Report

I do not think I am overstating that this has been one of Delta United Church's most challenging years so far. We have had all the usual difficulties with finances, building upkeep, and staffing issues. But we add to that, a major capital project in the new roof, the search for a new permanent minister, and COVID-19.

What I am most impressed with, in these trying times, is the wisdom and agility that the Council and the congregation, as a whole, has reacted to these hurdles. I feel we are a stronger and more committed group at DUC than ever before. Our determination and our faith have allowed us to take on these challenges and move the church forward in the best possible manner.

In a year of change, we have seen more than our share of that, saying goodbye to Rev. Shelley Smith, Heather Kilborn (Music Director), Denise Forget (Sunday School Coordinator), and Shelia Powell (Custodian). They all will be missed and we thank them for all that they have given to DUC. We also say farewell to Rev. Garry van Bruchem, who has completed a year with us, guiding us spiritually through the pandemic pitfalls. Thank you, Garry.

We now welcome Maggie Ford (Sunday School Coordinator), Christine Howard, who will fill in as Music Director on temporary basis, and Jocelynn Belmore (Custodian). I would like to thank Shiona Mackenzie (Office Administrator) and Bob Penner (Custodian) for their devoted service to Delta and their continued flexibility through staffing changes and COVID-19's ups and downs. I think it's appropriate the mention the hardworking efforts of Debbie Berquist and the Ministry and Personnel committee for handling so professionally and reacting so quickly to the large number of staff changes this year. Thank you, all.

With pandemic closures, we lost rental income making our finances shakier than normal. Then, when we opened again, the income skyrocketed, but, as I write this report, we are locked down again and do not know when that income will return. I would like to give a special thanks to Trish Fraser whose volunteer role has become so important and so difficult because of the ever-changing pandemic situation. Without her efforts, we would be in a very precarious financial situation.

I encourage everyone to continue to support Delta United church financially, or through your tireless work. We still need to raise \$6,000 to complete the roof campaign. We have raised just over 60% of the total needed. Our Search Committee for a new minister has made some progress, but we are in the early stages of talks, so it is difficult to know if this will bear fruit and, if so, when. We will keep you updated as more information is available.

I loved our success as a Zoom Sunday church when it was required. It felt, though separated by distance, we were still a thriving community. As we are now an Affirming congregation, I know we look to the future as a true beacon of faith and inclusion for all. It is great to be back in person and see the church activities quickly come to life again so quickly. No matter what the pandemic can throw at us, DUC is ready to face the future.

I wish to say to the congregation as a whole, what a privilege and pleasure is has been to chair the Council this year. The people of your Council are so capable and committed it makes my role easy. I look forward to the coming year, and I am confident in DUC's strength to overcome all obstacles and meet all challenges.

Regional Council (Horseshoe Falls Region 9) Report

Horseshoe Falls provided assistance to Delta United Church throughout the year, including finding Rev. Garry van Bruchem as our supply minister from February to the end of the year. Rev. Garry was willing to stay on for the year or, until the Search Committee was able to find a permanent minister to replace Rev. Shelley Smith.

Horseshoe Falls held two Regional Council meeting with the Communities of Faith: one in May and the other in November. The highlights of the meetings are listed below.

- Statistics received from communities of faith were previously used in determining assessment. The assessment will now switch to a revenuebased model that is believed to be a fairer system.
- Insurance companies have raised the rate to churches up to 30% this year. The main reasons for change are aging buildings and climate change.
- Horseshoe Falls Regional Council is now an Affirming ministry. The affirming service took place on June 6. DUC is also an affirming community of faith as are other churches in Horseshoe Falls Region.
- DUC raised \$1,230 for the Wesley Case for Kids Walk, Run and Ride. The Wesley Walk raised over \$90,000 when all the donations were counted.

Pastoral Care Report

Mission and Outreach Committee Report

Delta United Church's Mission and Outreach Committee (M&O) has been inactive for some time, for obvious reasons, around the COVID-19 pandemic. As in-person church meetings resumed in 2021, Judy Brown suggested the Committee resurrect Edith's Pantry.

The pantry had been idle since the closure of the church to in-person meetings and the departure of Rev. Shelley Smith. The M&O undertook a complete review of the entire contents of the pantry and disposed of all goods that had passed their due dates.

Approval was received from Council and a call for donations was presented to the congregation, with a goal to reopen the pantry in time for the 2021 Christmas season. As a result of the generous donations and assistance of the members of Delta United Church, as well as donations received from the "Kids-Only Shopping Day" the pantry was restocked and the goal of opening for Christmas was realized.

Hours of Operation of Edith's Pantry: Mondays from 10:00 a.m. to noon.

In addition, a grant proposal was submitted to the United Church of Canada Horseshoe Falls for funding to support and restock Edith's Pantry. We hope to receive the grant in February or March, 2022.

Our singing voices were silenced when COVID-19 forced the lockdown of all the churches in March 2020. However, early in 2021, we found other ways of bringing music to our congregation, as they remained sheltered in their homes.

During the weekly Sunday Services, Heather Kilborn and her partner, Patrick McPhail, continued to provide their professional musical performances on the flute and bass remotely, giving the people watching a safe outlet to sing or just listen, while in the comfort of their own homes.

When DUC decided to try a new technology called Zoom, an online chat service, a whole new world opened up for our church family and improved our Sunday services and social relationships. Heather and Patrick ventured out to our church with their new recording equipment, limited soloists, and followed COVID-19 guidelines, to record selected hymns for the Zoom service every week. Thank you, Patrick and Heather for dedicating your time and money to make all this happen safely.

On Sept 19, 2021, the church reopened, and, again, our choir members were tested with challenges. Heather returned to the Thunder Bay Symphony Orchestra (with plans to return when back on holiday, and at the end of May 2022 to continue as our Music Worship leader); we are currently looking for a replacement to fill the void. Meanwhile, we have been blessed with our musical friend, Christine

Howard, who has graciously made herself available on a week-to-week basis, until we find someone. Thank you, Heather and Christine.

With the church reopening, our choir had a breakthrough – Council agreed to a trial of live singing by limited soloists, socially distancing in the choir loft and wearing masks when not singing. Even better news arrived when, a month later, a request to allow more choir members to return to the choir loft was tabled and Council agreed to allow as many choristers to sing as deemed safe in consultation with Rev. Garry and the Music Director.

In closing, in 2021, as our church slowly emerged with new policies and procedures to protect each other from contacting the COVID-19 virus, our small DUC choir continued to entertain and be the congregation's singing voice as they hummed or just sat back to listen to our church music.

Meetings for the UCW did not resume until October of this year, however, the "Cold Hearts, Warm Feet" proceeded in February and, happily, some 144 pairs of socks were donated to Wesley Centre and we maintained our so well-appreciated tradition.

At that first meeting, in October, we were pleased that 12 women attended and gave us a start to a very ambitious fall. The main kitchen has suffered from neglect in the last 18 months, so crews descended on it and now, after some hard work scrubbing, clearing, washing linens and all that involves, it looks much better. With help from additions to the UCW, 500 meat pies and 70 macaroni and cheese pies were made. Then the UCW held a very successful Bake Sale in December.

As an outreach project, over 70 shoe boxes were filled with toiletries and small gifts for senior men and women who might need a little cheering or help. The idea for this project was taken from the shoe boxes filled for children at Christmas time, which were given to service agencies for distribution as well as the few that were delivered to specific names given to us by some of the agencies.

These things were all accomplished by our expanded numbers, and in November there were about 18 in attendance at our regular meeting. It is something which we hope will continue as the UCW group strives to meet the needs and expectations of Delta United Church.

Treasurer's Report

2021 was another interesting year, but thanks to the generosity of our congregants, and benefits provided to small businesses by the Canadian Government, Delta United Church was able to fulfill all of its financial obligations and end the year with a positive cash flow. In addition, we also were able to spend more than \$25,000 to replace the roof of our church. I believe we are all to be congratulated for our performance.

Highlights

- We ended the year with more than \$51,000 in envelope offerings.
- We received more than \$9,000 in donations to be put towards our new roof.
- DUC received more than \$15,00 in rebates via the Canadian Emergency Wage Subsidy Program (CEWS)
- DUC also qualified for an interest-free \$60,000 CEBA Loan (Canadian Emergency Business Account), 20% of which will be forgiven if the loan is repaid by the end of 2022.

As of December 31, 2021, Delta United Church has \$58,824.42 in available funds. A summary of all Receipts and Disbursements follows.



TYPICAL CHURCH COUNCIL MODEL



Board of Trustees

- responsible for all property, including the sale, maintenance, new building and use of said property, because the title to all property is in their names
- maintains and invests all funds that are donated as a memorial, or gathered from the sale of church assets

Finance

- maintains and deploys the assets of the Congregation to fulfill the mission of the Congregation
- secures contributions for the current expenses of the local Congregation, including the salary of staff, presbytery allocations, and the Mission and Service Fund of The United Church of Canada
- disburses the money received for these purposes according to a Congregationally approved budget
- secures contributions from participants through regular giving, including pre-authorized remittance (PAR)
- presents regular reports on the condition of finances and property to each meeting of the Board

Ministry and Personnel (M&P)

- provides a confidential consultative and supportive agency for the staff of the church and for members and adherents of the Congregation(s)
- reviews working conditions and remuneration for all staff
- oversees the relationship among staff and all members of the Congregation
- annually reviews and evaluates staff
- regularly reviews the responsibilities of all staff of the pastoral charge and revises position descriptions when requested by the Board/Council

Mission and Outreach (Community/World Engagement)

 oversees the outreach of the Congregation in evangelism and social action within the community, city, country, and world

Pastoral Care

- ensures those within our church family who require special attention and prayer are taken care of
- ensures the cards are sent during special occasions

Property

- manages maintenance of the building, both inside and out
- manages maintenance of the all equipment
- secures, maintains, and works with all renters of the building

<u>Service</u>

- coordinates opening the doors and the sanctuary, setting up the microphones, making and setting up pre-service coffee and tea, turning on the lights, lighting candles
- ensures all is put away, turned off, closed, and candles blown out at the end of service
- mans the chair lift before and after each Sunday service

Worship and Christian Education

- coordinates the Christian education of all young and old
- coordinates worship and special services
- keeps the roll of the Congregation and a record of children and adherents
- keeps the register of baptisms, marriages, and burials
